**PACKAGING:** The product is crated in a custom sized REBUL create with reinforced base & protective wrapping (Aerothene, SFK cardboard and pallet wrap). It is the buyer's responsibility to advise on additional packaging requirements to allow successful delivery of this product. The cost for this is excluded from this quotation. The cost of uncrating, unwrapping, removal of packaging and positioning of the items is not included.

**LEAD TIME:** All items are made to order. Normal production lead time is 6-8 weeks from date of order confirmation (receipt of deposit) to dispatch from production premises depending on production capacity at time of order.

**MANUFACTURING:** Items are made by hand and to order – slight discrepancies occur. Items are only suitable for interior use. Please note that each natural stone and timber inlay has a different character and appearance due to the nature of the material. Natural stone selection is subject to availability.
