Pricing

- All unit prices are quoted exclusive of VAT, fabric/leather, and shipping.
- Felt pads and plastic glides are not standard to Woodbender products due to the variety of floor surfaces available. They are available on request at an additional cost. Please discuss this with us.

Fabric/Leather

- Fabric/ leather is not included in the product price. You are welcome to supply your own fabric or specify a fabric that we will order on your behalf.
- Fabric calculations are based on plain fabric and a roll width of 1.4m wide, unless otherwise discussed. Please note that for upholstery pattern match, prominent direction pile and suede, we will need to add 25% to the final meterage required.
- Leather calculations are based on m², we can assist you in calculating the square meterage required. As leather is a natural product, markings, and defects such as scars and cuts are to be expected. We are not responsible for the cost of replacement hides.
- All fabric/leather needs to be delivered to our factory by an agreed upon date to not hold up the production of your order.

Timber Finish

- All furniture is made at our factory in Strand, Western Cape, South Africa. We use solid Ash timber, and all products are available in 5 standard stain options, Natural, Light Brown, Dark Brown, Black, White.
- Please note that wood is a natural product and variances in grain and colour are to be expected.
- Custom stains are available at an additional stain matching fee. We also require a sample of the wood colour on a piece of wood to accurately stain match.
- For top-up orders we require a sample product from the previous order to stain match to in order to ensure the new batch matches correctly.

Shipping

- All orders are dispatched from our factory in Strand, Western Cape, South Africa.
- We can manage the shipping for you, alternatively you can arrange to have your order collected yourself.
- All products are boxed for protection whilst in transit.
- Speak to us about international deliveries, we are SADEC registered and are regularly exporting globally.
- Installation dates must be disclosed when the order is placed to ensure they are within our lead time and our production team can manufacture accordingly.
- Woodbender will not store orders in the event of site delays. Arrangements can be made for your goods to be stored at our courier's warehouse, which we will quote you on. The balance payment and additional storage costs will need to be paid before they dispatch from our factory.

Maintenance

- All products are strictly for indoor use only.

- We offer a 6-year structural guarantee on all our chairs and stools and a 2-year structural guarantee on our solid tops for any defects that may occur during normal usage.

Payment terms

- We require a 50% deposit up front at the point of confirming your order.

- No orders can go into production without receiving the POP for the deposit.
- Similarly, we will not dispatch any orders until the POP for the balance has been received.
