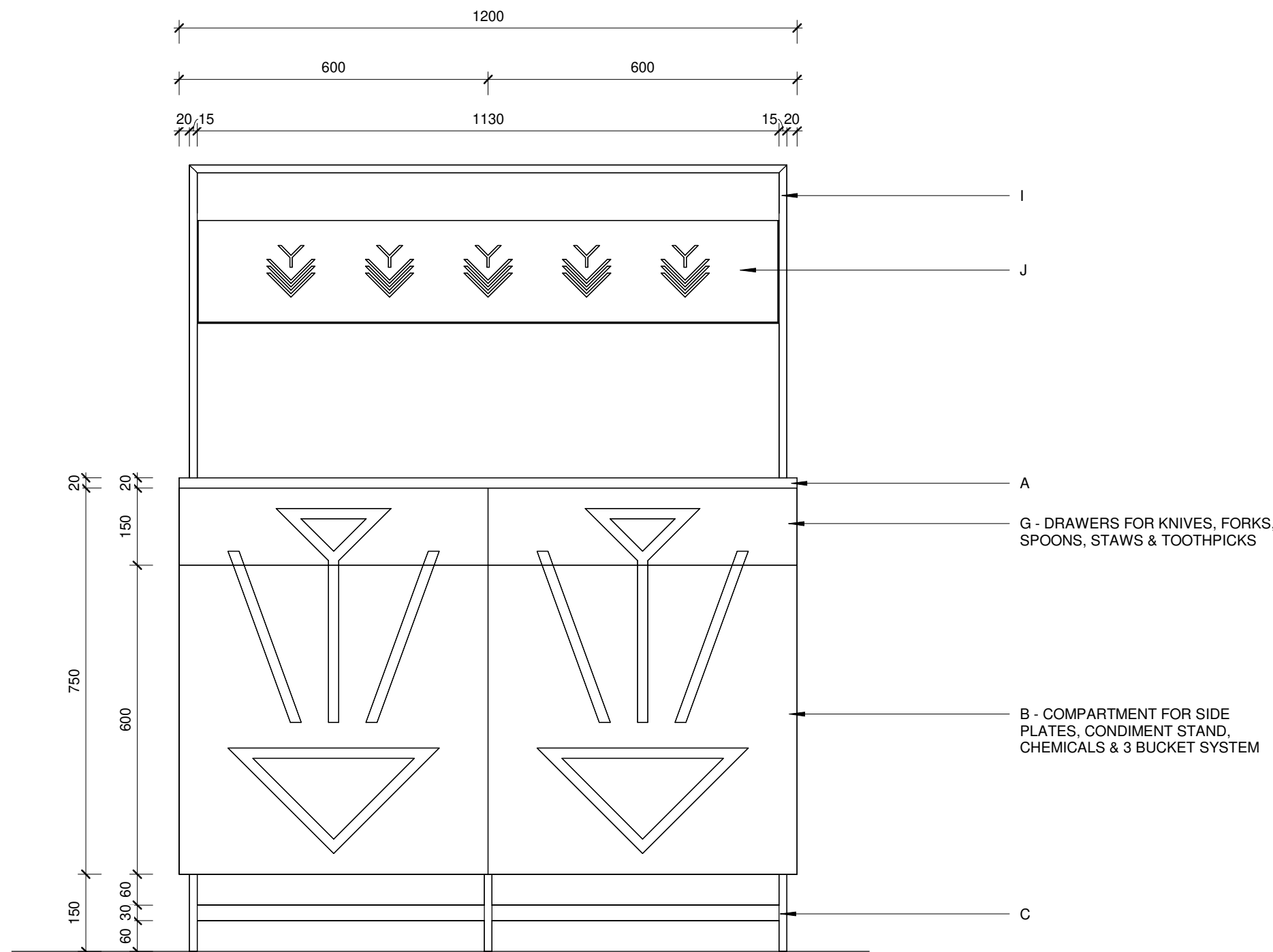
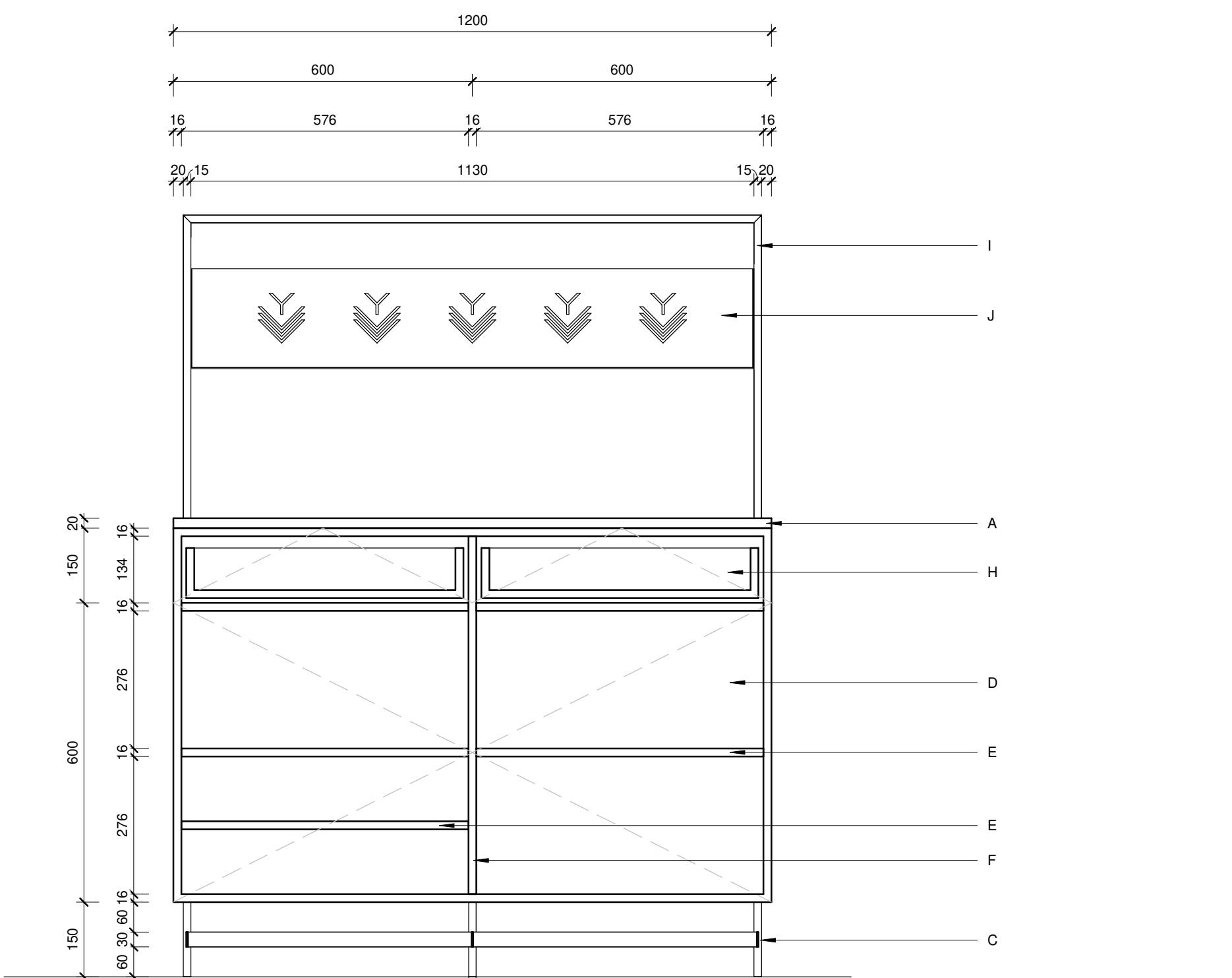


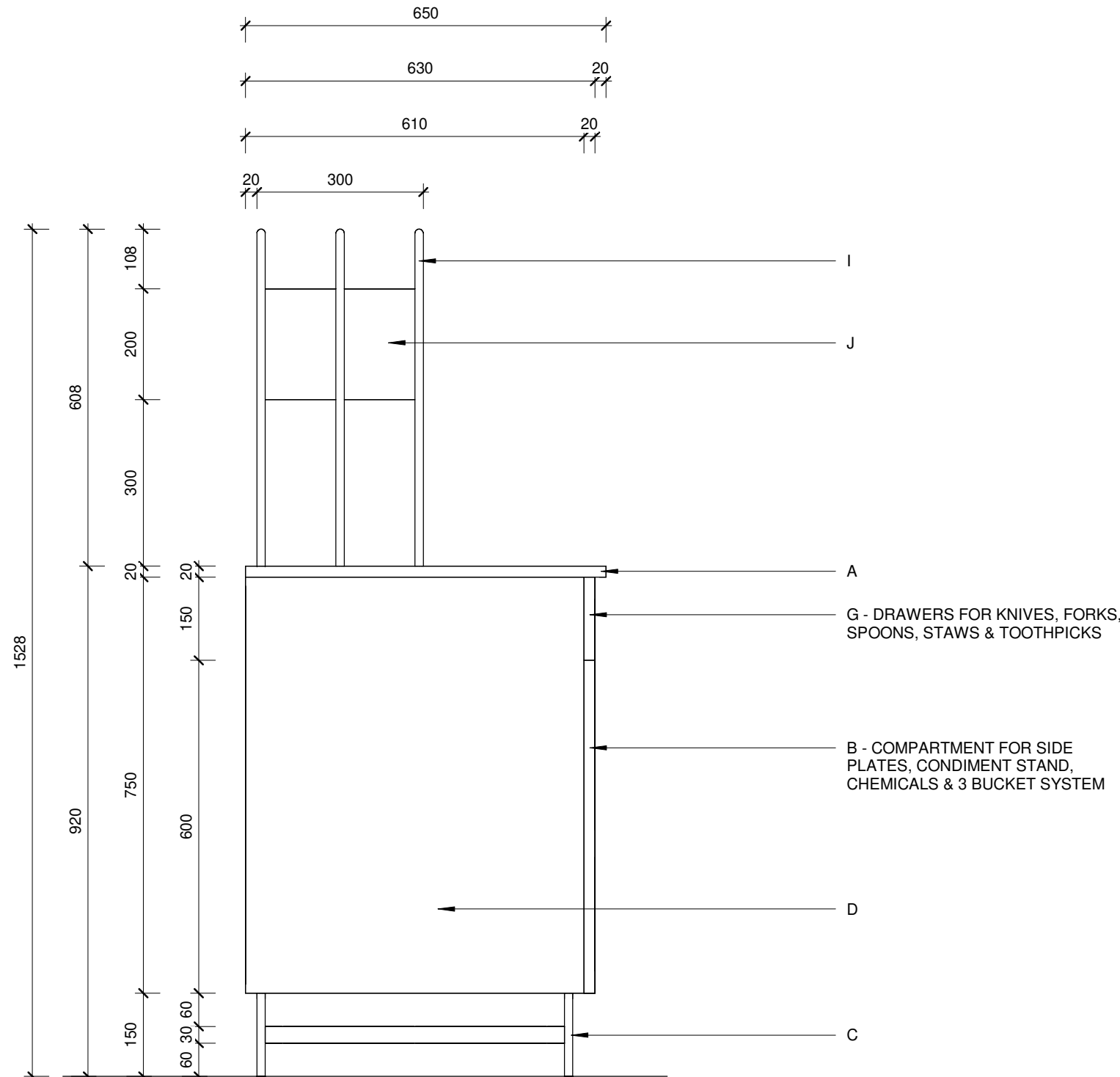
1 PLAN OF CONDIMENT STATION

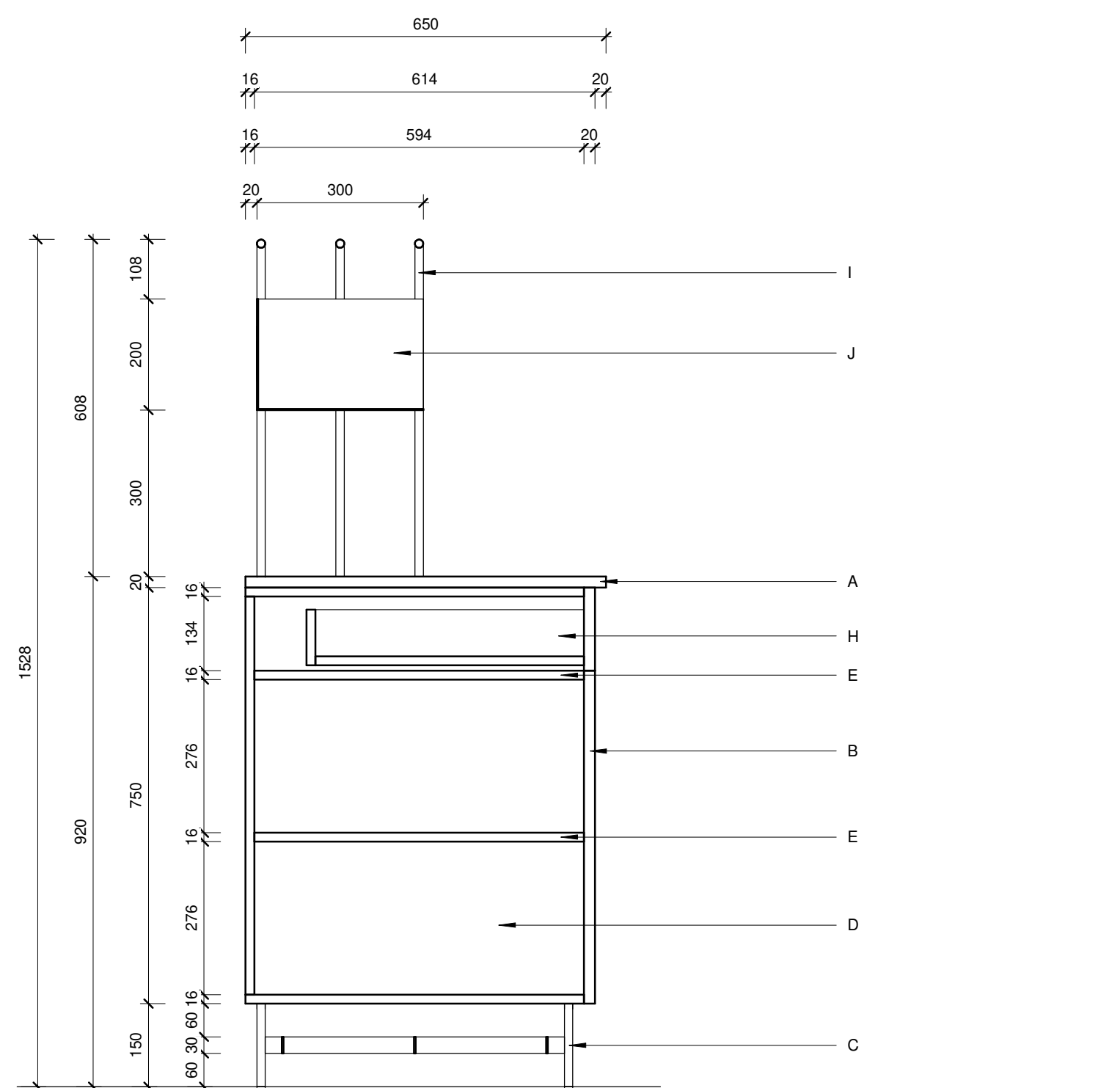
2 FRONT OF CONDIMENT STATION

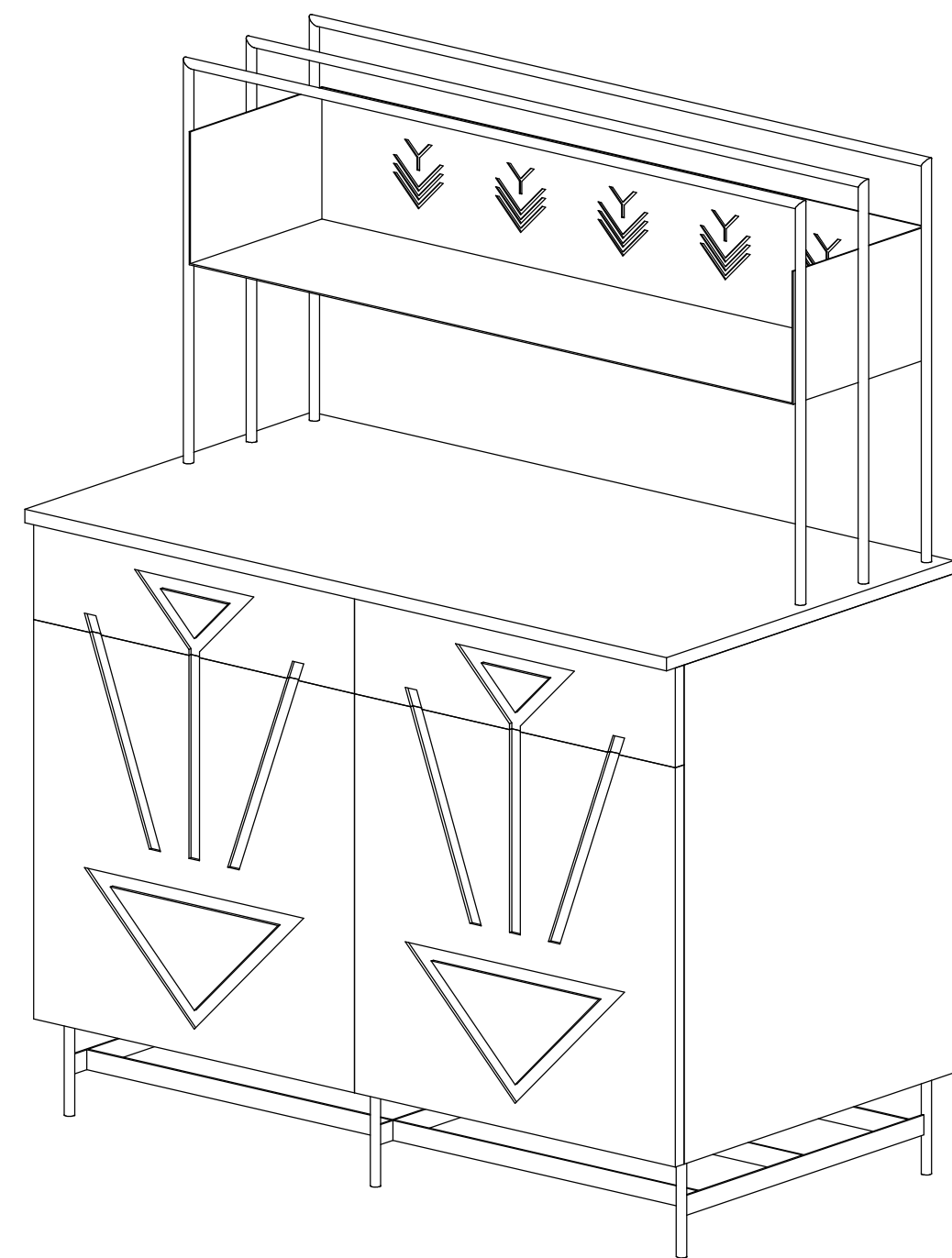
4 SEC FRONT OF CONDIMENT STATION

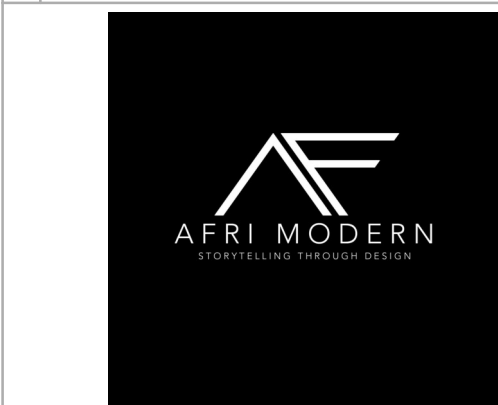
